## Management Staff Update: Marsha Gray reported

- Electronic reporting and payments Gray shared that this reporting service will be more advanced and costly to set-up than initially thought. Gray has been speaking with the Soft Wood Lumber Board as they are working to put together a similar system.
- Campaign Updates:
  - Gray encouraged the Board to check out the updated website (<u>www.itschristmaskeepitreal.com</u>) as it is displaying the new tree species guide and retail locator. The locator is not complete, hoping to have individual registrations showing soon.
  - The CTPB paid for an e-blast with 22,000 Garden Centers around the U.S., encouraging them to register for the locator.
  - The "How Does it Grow" segment is almost complete the harvest segment is the last portion to be filmed, which will take place next week. The completed segment is set to air the week of Thanksgiving.
  - "Dad How Do I" will be filming next weekend. This segment is set to air around November 16<sup>th</sup>.
  - City Mom's Collective (blogging influencers) all promotion pieces have been written and are in the process of getting reviewed. These pieces will be released before Thanksgiving.
  - The first Press Release went out on Monday, October 26<sup>th,</sup> and the second Press Release is scheduled for November 11<sup>th</sup>.
  - Gary Westlake suggested reaching out to the State Landscape and Nursery Associations to get the Garden Centers to register for the locator.
  - Bill Brawley shared the project with Chuck Toombs at Oregon State University is moving forward.
